24. DECLARATIONS OF INTEREST

25. MINUTES

RESOLVED That the Minutes of the Meeting of the Parish Council held on 13 May 2015 (Minute Nos. 1 - 22) as circulated, be approved as a correct record and signed by the Chairman.

26. CHAIRMAN'S ANNOUNCEMENTS

Packington Sign

Councillor R Barnes informed Members that the Packington Sign half way up Hopwas Hill on the left hand side (Tamworth to Lichfield) which was bent back and a branch had fallen onto the sign had still not been repaired.

RESOLVED That a further email be sent to Staffordshire County Council, as Highway Authority, asking that the fallen branch be removed and repairs made to the Packington Sign.

Whittington Arms

Councillor R Barnes informed Members that the 'grip' which needs cleaning out on the road by the Whittington Arms (Lichfield to Tamworth) had still not been cleaned out.

RESOLVED That a further email be sent to Staffordshire County Council, as Highway Authority, asking that the 'grip' be cleaned out.

Bridle Path - Old London Road and A38 Bridge below Swinfen Hall

Councillor Elliott informed Members of the current situation regarding the bridle path at the Old London Road and A38 Bridge below Swinfen Hall.

(2) That a further email be sent to Highways England (formerly the Highways Agency) regarding the lighting on the A38 entrance/exit to the Swinfen Estate.

33. PLANNING APPLICATION 15/00485/FUL AND 15/00486/LBC PACKINGTON HALL, TAMWORTH ROAD DEMOLITION OF EXISTING COMMERCIAL/MANUFACTURING UNITS AND CONVERSION OF PACKINGTON HALL TO FORM 4 NO. APARTMENTS AND ERECTION OF 20 DWELLINGS AND ASSOCIATED WORKS

Members were informed that a planning application had been received by Lichfield District Council relating to Packington Hall, however, the application had not yet been received by the Parish Council.

RESOLVED (1) That once the application had been received by the Parish Council that full details be forwarded to all Members of the Parish Council.

(2) That the initial comments of the Parish Council were that there was no objection to the demolition of the existing commercial/manufacturing units and conversion of Packington Hall to form 4 no. apartments, however, there was an objection to the erection of 20 dwellings as this was felt over intensive use of the brownfield site, the dwellings proposed were very substantial and access/egress as this was a single track of 8 foot x 6 foot. It was proposed that 10 dwellings would be more acceptable on the site.
