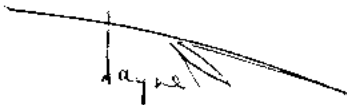

Planning Application 17/00783/COU

Land adjacent Keepers Cottage, Packington Lane

Change of use of land and erection of commercial livery stables (associated with Keepers Cottage, Packington Lane)

The Chairman confirmed that an email had been forwarded to all Members of the Parish Council (including District Councillor Yeates) relating to planning application 17/00783/COU as Lichfield District Council, as Local Planning Authority, had sought comments from the Parish Council between meetings. This is not unusual as the Parish Council only meets every two months. Several Councillors had indicated that they had no objection so the Parish Clerk had forwarded this comment to Lichfield District Council on 05 July 2017.

The Chairman proceeded to inform Members of the background to this application and stated that no other comments had appeared on Lichfield District Council's planning portal (12 July 2017). However, a resident from Packington Lane had approached the Parish Council. Councillor Dyott felt that no formal objection had been raised (nothing to warrant the Parish Council's attention).

It was **RESOLVED** that all Members present endorsed the action taken by the Chairman.

Local Councils, Internal Drainage Boards and other Smaller Authorities in England Annual return for the year ended 31 March 2017

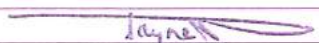
