### PARISH FORUM

No members of the public were present.

### 27. APOLOGIES FOR ABSENCE

None as all Members were present.

### 28. DECLARATIONS OF INTEREST

Councillor Armstrong declared a disclosable pecuniary interest in Planning Application 19/01205/FUH - Evergreen, Packington Lane.

Councillor Mrs Pope declared a disclosable non pecuniary interest in Planning Application 19/01205/FUH – Evergreen, Packington Lane.

### 29. MINUTES

**RESOLVED** That the Minutes of the Meeting of the Parish Council held on 10 July 2019 [Minute Nos. 15-26] as circulated, be approved as a correct record and signed by the Chairman.

### 30. CHAIRMAN'S ANNOUNCEMENTS

### Packington Hall

The Chairman informed Members that the re-development of the site was rolling on slowly and that he had received a text message from Mike Strurdy informing him that machinery and diggers would be on site on Monday 16 September 2019 [excavating and clearing out the remediation required for the build] and hopefully breaking ground mid-October 2019.

### Swinfen Prison

The Chairman informed Members that a Prison Warden had resigned two weeks ago due to nine knife attacks on staff.

### St Mary's Church, Weeford

The Chairman made reference to St Mary's Church in Weeford and in particular to the Reverend Dr Jason Phillips who had recently been upsetting the parishioners. The Chairman stated that funds which had been left by a parishioner for the kitchen had been used elsewhere.

### 31. THE HIGH SPEED RAIL PLANS

The Chairman informed Members that former Councillor, John Barnes, had recently met HS2 representatives who had agreed to take over all of Packington Moor and outbuildings by 30 December 2019. HS2 representatives stated that they intended to turn the site into a storage area.

Councillor Loescher pointed out that he did not think Packington Moor was designated as a compound in the Hybrid Bill for HS2 and planning permission was for agricultural use only.

Councillor Loescher informed Members that representatives from HS2 had confirmed that the 5m bund would require planning permission.

The Chairman informed Members there was no electricity at Packington Moor.

Councillor Dyott informed Members that he had written to Christopher Pincher MP asking Mr Pincher what he proposed to say at the Review Panel bearing in mind the negative effect/impact on the Parish and in light of Mr Pincher's stated position of being against the project and having voted against it at the Second Reading. Councillor Dyott confirmed that no response had been received from Mr Pincher.

### **RESOLVED**

That an email [drafted by Councillor Loescher] be sent to HS2 enquiring whether planning permission would be needed to change the use of the land from agricultural to storage use at Packington Moor and request that they also submit a consider a planning application at the same time for a 5m high tree covered bund [as measured from the higher of the track and ground level between Jerrys Lane and Packington Moor].

That an email [draft by Councillor Dyott/the Clerk] be sent to Christopher Pincher MP to ascertain what he is going to say at the Review Panel.
