Mrs Danby would charge £25 per annum.

12. STAFFORDSHIRE PARISH COUNCILS' ASSOCIATION (SPCA)

Members are requested to consider renewal of membership of the SPCA at a cost of £143 per annum.

The Association was founded in 1939 and:

- Saves you time and money by streamlining your Council's "business" using model documents.
- Provides legal/financial advice.

- Suggests sources of funding for projects and provides guidance and advice on public sector borrowing approval
- Provides access to a database of suppliers who provide products and services for Councils, website design, Council notice boards, playground equipment, shelters, bins etc.

13. PARISH COUNCIL'S INSURANCE – AON LIMITED

15. THE HIGH SPEED RAIL PLANS

Members are requested to debate the impact of the High Speed Rail plans and the impact thereon to Swinfen and Packington.

Express and Star dated 07 March 2011 -

Lichfield's Guildhall is to stage a two-day public consultation event over the high-speed rail line that would pass through the district. Residents will be able to have their say on HS2 on 08 June and 09 June at the Bore Street building.

The city's MP Michael Fabricant is urging people to make their views known on the proposals for the £32 billion project which involves trains travelling at up to 250 mph. He said the consultation is an opportunity for people to learn more about the route and say whether they believe it is really necessary.

Mr Fabricant said: "Needless to say, national anti-HS2 groups will be arguing forcibly whether HS2 is really necessary or whether an upgrade to the West Coast Main Line will obviate the need for HS2. This debate will be well publicised over the coming months and years in the national media".

The Transport Select Committee of the House of Commons is conducting a separate independent - and - unwhipped - inquiry into the economic arguments for and against HS2. The upgrading of the existing West Coast Main Line has been ruled out as an option because it would cause a decade of disruption and cost £800 million more.

Staffordshire County Council has already objected to the line which would connect the northwest and Birmingham to London. Following its visit to Lichfield, the consultation will visit Birmingham Museum and Art Gallery on 18 and 19 June.

16. WEEFORD CHURCH

Members are requested to consider making a financial donation towards Weeford Church. The Parish Council has every year donated an amount of money to help maintain the burial ground at Weeford as it is the local parish church. £300 was the figure donated last year.
